Consent and Declaration: Information provided to CIC is obtained under the Immigration and Refugee Protection Act (IRPA) to belong to Canada through an entry permit. Information that becomes information can be given and other rights, such as but not completed to: "Canada Border Services Agency (CBSA)", "Royal Canadian Mounted Police (RCMP)", "Canada Security Intelligence Service (CSIS)", "Department of Foreign Affairs", "Trade and Development (DFATD)", "Canada Employment and Social Development (ESDC)", "Canada Revenue Agency (CRA)", a regional government administration or the state government and government administration under contract with paragraph 8 (2) of the Data Protection Act. Information may be disclosed to foreign government agencies, law enforcement agencies and detention centers regarding the management and implementation of immigration legislation, provided the disclosure of the information does not pose a risk to individuals and / or their families. Information can also be systematically validated by other government administration systems to validate a status or identity and be part of their update program.

If biometric data is required as part of an application, the collected fingerprints are saved and shared with the RCMP. The country of Canada reserves the right to share immigration information related to biometric records with foreign governments that have entered into an agreement or agreement with Canada.

Depending on the nature of your application, the information provided will be stored in one or more databases (Personal Information Bank (PIB)) in accordance with paragraph 10 (1) of the Canadian Data Protection Act. Every person has the right to view their personal data, which are stored in the respective databases (PIB), in accordance with the Canadian right of access.
